
The Greenhouse Gas Accounting Tool


The tool produces summary tables and charts to help councils understand their most significant sources of emissions, which can then be used to prioritise actions to reduce carbon emissions.

Councils are also able to benchmark their emissions with other councils to understand how their performance compares with their peers using <u>LG Inform</u>.

Recently updated to include Scope 1, 2 and basic Scope 3 emissions.

Local Action For Our Environment podcast

The LGA have released a podcast series to provide advice and guidance for council officers and Members looking to engage their local communities on climate change.



Across the United Kingdom, councils are taking urgent actions in their local areas with partners and their local communities to combat the negative impacts of climate change and to deliver net zero carbon by 2050. To help councils reach these targets, the LGA has recorded a new podcast series — Local Action For Our Environment.

This podcast is a training resource for council officers and Members, supporting councils on a local pathway to net zero and enabling them to fight climate change locally with the tools, techniques and know how.

The focus of this series is on the climate crisis and how councils can create meaningful engagement with communities on climate change, enabling local climate action, developing tangible evidence and plans for how they are tackling climate change in their areas.

Hearing from a variety of councils and experts across five episodes, council officers and Members can learn about a range of different techniques which can be deployed to engage with local communities, and how to overcome the challenges which may arise along the way.

Changing behaviours to reduce climate change and protect our environment

Climate change communications

Climate change issues have long been important topics for central government and local authorities. Local authorities are developing tangible evidence and plans for how they are tackling climate change in their areas.

Six steps to undertaking a climate behaviour change project

Looking at the six steps you can take to begin a behaviour change project to tackle climate change in your community.

- Step 1: Before you do anything else, think precisely about the behaviour that you are trying to change what, who, where, when, how?
- ∨ Step 2: Understand what is driving the current behaviour
- Step 3: Choosing your intervention
- Step 4: I know what is driving the behaviour. I know what intervention types I could use. How do I but them together?
- Step 5: What happens if you end up with too many options, and you cannot choose between the intervention types?
- ∨ Step 6: How can you measure whether your intervention has worked?

How can we apply this six step guide to our local climate behavioural challenges?

A series of climate change behavioural challenges can be found in this resource. Each will need to be modified for your local behavioural diagnosis and context but they provide a starting point for thinking about the behaviour which you want to change, the questions you may wish to consider in your behavioural diagnosis and examples of interventions to set you well on your way to making local changes.


