Actions from last meeting:

- Adam Stewart to seek clarification over any restrictions for BNG delivery on council-owned land. Complete PAS FAQ answer on this topic is as much Defra can say about this at this point.
- Discuss local government budget concerns and the risk this places on environmental capacity
 with Environment Board to discuss more broadly whether there is any action ADEPT should be
 taking in respect of this matter. Complete impact on place services generally discussed through
 ADEPT, including survey of members. David to follow up results of survey and share with group.

2. Local Nature Recovery Strategies

2.1 Environment Agency role in Local Nature Recovery Strategies

See presentation received from Jim Davies (EA), Will Cole (NE) and Andrew Canning-Trigg (FC).

The LNRS:

- Builds on a lot of existing work and partnerships.
- Is a driver for climate resilience and adaptation, sustainable healthy places and wellbeing; provides a strategic platform for natural solutions to climate change.
- Will support catchment scale planning and working on a catchment basis.

- Will have a role in regeneration and green infrastructure.
- Can be used to identify tree cover opportunities when mapping against air quality, heat etc climate impacts.
- Provides a strategic approach to natural capital.
- Provides opportunity mapping.
- Will inform planning will link in and sit alongside.

For the Defra arms length bodies, Natural England is first point of contact for LNRS but all will be involved in its development. Environment Agency will have duty of regard to LNRS.

Discussion:

- Changes to planning system and removal of SPDs in future this will lead to a void of local guidance, which poses an inherent risk. Need clarity on links between LNRS and BNG and planning reform. Noted that there will be statutory guidance on how planning authorities should use LNRS in planning.
- Who "owns" the strategy responsible authority is responsible for development but should it be owned by all local partners. Does Strategy need delivery plan to sit under it, with responsibility identified. LNRS should be influencing local direction and making partners take ownership but a delivery plan will not be a statutory requirement – will be for local level to decide (noted that all the pilots developed a delivery plan).
- Any knowns on the timescale yet? Resulting in difficulties in linking in with local plan reviews. No
 hard deadline for delivery. Elements such as strategic priorities and areas that are emerging can
 be used in interim in local plans.
- What are RAs spending their seed money on?
 - Recruitment dedicated project officer. Noted that recruitment is going to be difficult.
 - o Comms and engagement plan
 - Noted that money can be carried over and that Defra will be asking RAs to return info on how they are spending the seed funding
 - Data audit and gap analysis.
 - Mapping
 - Web development.
 - Bucks have seen the value and potential of the LNRS. Capacity was an issue for the pilot
 so using funding to bolster partner capacity.
- Can we have an idea of timelines for regs and guidance, so we know how long we have to review and digest before commencement in April.
- Planners are really keen to hear from DLUC now on how LNRS links into local planning (and BNG).
- Ministers are working through the draft LNRS and BNG regs and guidance but cannot give a
 definitive date.
- NE developing a network and online resource for RAs, plus support for cross border working.
 Noted that Q&A on PAS website for BNG is really helpful and something like this for LNRS would
 be welcomed. PAS NRN project noted it is working with NE and Defra on some FAQs that have
 come up during events, which will be uploaded shortly (link copied in notes below). Need to
 make sure PAS work doesn't duplicate what NE are intending to do.
- Sitting tight isn't necessarily working for LPAs who are doing their own things with targeting BNG and supporting policy.

2.2 PAS NRN update

See presentation from Krista Patrick.

In summary:

- Working on case studies.
- Nature recovery page on PAS website is now added includes a library of good practice examples of nature recovery.
- Emerging insights:
 - Clarity and certainty of funding
 - o Embedding nature into wider corporate priorities
 - Value of coordination and partnership
 - Variety of timetables and frameworks
 - o Importance of regs, guidance and governance.
 - o Evidence and consistent data and the resources to interpret it.

In the discussion it was noted that a session to help elected members understand the benefits of nature recovery would be really helpful.

Noted that ongoing work includes:

- Updating and managing web resources.
- Practitioner network.
- EA river metric training.
- Developing more case studies.
- Wider stakeholder engagement e.g. RTPI; enforcement and legal; and private and third sector, who can support planning authorities.

What's next:

- Essential planning duties in Environment Act.
- Targeted support for different LPA groupings, considering experience and knowledge.
- Tools and resources for LPAs to use themselves, in addition to training and information.
- BNG readiness checklist and toolkit to review LPA services.
- BNG essentials training module for others to use.
- Topic based training.

Discussion:

- Project thanked for all its work and support has proven really valuable, especially the Basecamp forum. The discussions on basecamp are really useful when trying to work through the questions thrown up by preparations. It was noted that funding had been extended to March 2024.
- Regional workshops were suggested.
- Questions over how BNG register will work would be a useful training session once more is
- Noted that BathNES has just adopted it BNG policy.
- Prediction of offsite demand how to do this? Noted that the next PAS session is on offsite delivery.
- Monitoring/recording/reporting and enforcement topics for training would be welcomed. How
 does this work on and offsite; and out of area/region?
- How do we ensure that a development's own sourced offsite option is appropriate what assurances and standards are there? Need for national approach. NE assurances project noted.
- Cumbria have commissioned work to answer some of the questions regarding BNG delivery. Will share in due course.

4. Environment Act

4.1 Biodiversity Net Gain

- Expecting metric 4.0 to be released in February.
- Expecting Government response to BNG consultation soon with Ministers.
- Noted that the national BNG credit prices are expected to be published in Spring in order to give stakeholders as much advanced visibility before mandatory BNG in November.
- Query over BNG requirements for public funded projects and permitted development e.g. DfT projects.

Action: Adam to take query regarding BNG requirements for funded projects and permitted development back to relevant Defra teams.

4.2 Local Nature Recovery Strategy

- Expecting secondary legislation and guidance to be published soon with Ministers.
- All RAs have been contacted about seed funding.

4.3 BNG Duty

BNG duty has commenced - the following provisions of the Act came into force on 1st January 2023— (a) section 102 (general duty to conserve and enhance biodiversity); (b) section 103 (biodiversity reports). <a href="https://doi.org/10.103/journal-new-months-number-10.103/journal-number-10.103/j

It's a short signposting guide for organisations with an interest in natural capital, economic development and growth and prosperity such as local authorities, combined authorities, local enterprise and local nature partnerships, and is designed to complement more comprehensive guides such as ENCA and NE's Nat Cap Evidence Handbook.
