LGA Update

Speaker: Sonika Sidhu, Assistant Director of Policy - Place, LGA

Focus areas:

• Devolution Bill: governance concerns, climate and culture competencies.

- Councillor pensions announcement (mini win).
- Strategic planning and skills discussions with combined authorities.
- Climate duty: supported if funded; legal implications under review.
- "Force for Growth" initiative to highlight councils' role in economic development.
- Awaiting housing and homelessness strategies.
- Waste: concerns over industry influence on EPR; awaiting further detail on simpler recycling.
- Budget submission aligned with government missions, awaiting fair funding review response.
- Positive engagement with new ministers and Labour front bench.

Actions:

- Consider future agenda item on fair funding implications for the South West.
- Consider future agenda item on climate duty and devolution impacts.

Presentation from NISTA: 10-Year Infrastructure Strategy Speaker: Greg McClymont, Head of Infrastructure Spatial Planning, NISTA

Notes:

- NISTA is a new Treasury sub-department focused on infrastructure strategy and delivery.
- Strategy include £765bn investment over 10 years across economic, housing and social infrastructure.
- Emphasis on spatial planning, infrastructure pipeline (777 projects) and enabling private finance.
- Introduced a national infrastructure spatial tool for cross-sector analysis.
- Strategy aims for support placed-based planning and improve delivery pace.

Actions:

- Share link to infrastructure pipeline dashboard and spatial tool (when available).
- Explore opportunities for local authorities to access and use the spatial tool.
- Provide feedback to NISTA on tool accuracy and local relevance.

Presentation from Somerset Council: Gravity/Agratas Project Speaker: Paul Hickson, Service Director for Economic Development, Skills and Climate, Somerset Council

Notes:

- Gravity site near Bridgwater is a major brownfield redevelopment.
- Agratas (Tata Group) investing in batter manufacturing for clean mobility.



OFFICIAL - SENSITIVE

- First building (150,000 sqm) underway; full site to host 3 buildings and ~4000 jobs.
- Strong infrastructure: M5 access, rail head, energy grid, water.
- Local Development Order (LDO) enabled fast-track planning and investor confidence.
- Lessons learned from Hinkley Point C applied to skills, housing and community engagement.

ADEPT Update

Speaker: Kylie Russell, Deputy CEO, ADEPT

Transport / Infrastructure

- 1. Carbon Leadership Programme: There's been significant interest in the programme since we launched it in June, and places are limited for the remainder of the 2025/26 programme. Created in partnership with Proving Services and supported by the Department for Transport, the programme is designed to support local highway authorities measure and identify ways to reduce their carbon emissions. Rather than each authority investing considerable time and resources into developing its own carbon baselining tool and working in isolation with limited visibility of comparative performance, the programme offers a coordinated approach.
- 2. **Live Labs 2:** As part of the programme we commissioned the Behavioural Insights Team to explore the behavioural changes needed to run alongside technological change (see the report here). We have launched a pledge that invites stakeholders to drive meaningful decarbonisation across all aspects of the UK's road network and rethink how the highways infrastructure reduces carbon for more information and to sign the pledge, see here. The latest Live Labs 2 blog focuses on the Devon A382 project (here).



3. The 7th **National Traffic Managers Conference** is now being held online on Weds 8th Oct (it was meant to be held in Birmingham). The programme, and registration link, can be seen here.

Devolution / Growth / Planning


- 4. **LGR & Devo webinars:** Our programme of support for members on Devo and LGR issues has now completed. We delivered 6 webinars: 1) becoming a unitary council 2) becoming a combined / statutory authority plus issue-specific webinars on Environment & Climate Change, Highways & Transport, Planning and Waste & Recycling. - 5. **Workforce issues:** Our Gen Z 'Find Your Path' campaign has been shortlisted for an award in the CN Workforce Awards 2025. The campaign was designed to inspire the Gen Z generation to explore careers in local government, directly addressing our urgent skills shortage. We've just published the debrief report, that captures key learnings from the campaign read the report here.
- 6. We have published a policy position paper on the **Devolution Bill** (<u>here</u>). Whilst the association welcomed the introduction of the Bill, and the opportunity it presents for strengthening local leadership and place-based service delivery, we are very disappointed that the Bill does not propose to transfer or introduce new statutory environmental or climate-related functions to Strategic Authorities.

- 7. In the most recent **climate change blog**, ADEPT policy officer David Dale discusses recent developments in some local authority climate policies and the implications these changes may have (see here).
- 8. PACE Programme 2025: The outputs from session one are now available, including a summary, video and blog. The first session: 'Translating global trends into local place leadership: opportunities and challenges', explored four critical megatrends reshaping place outcomes: climate volatility, spatial inequality, erosion of trust and demographic and digital shifts. The session summary brings together the key learnings and discussion points from the day. The video provides an overview of the session's key themes and insights from the expert speakers. We've also published a blog from Matt O'Neill, Barnsley Metropolitan Borough Council.
